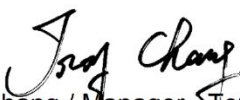

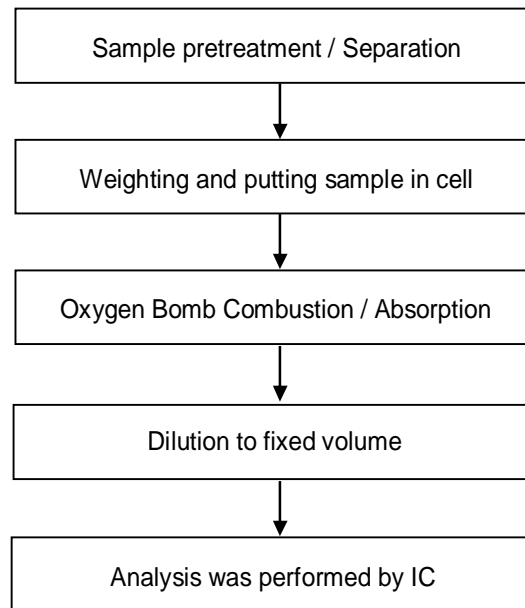

Analytical flow chart - Halogen



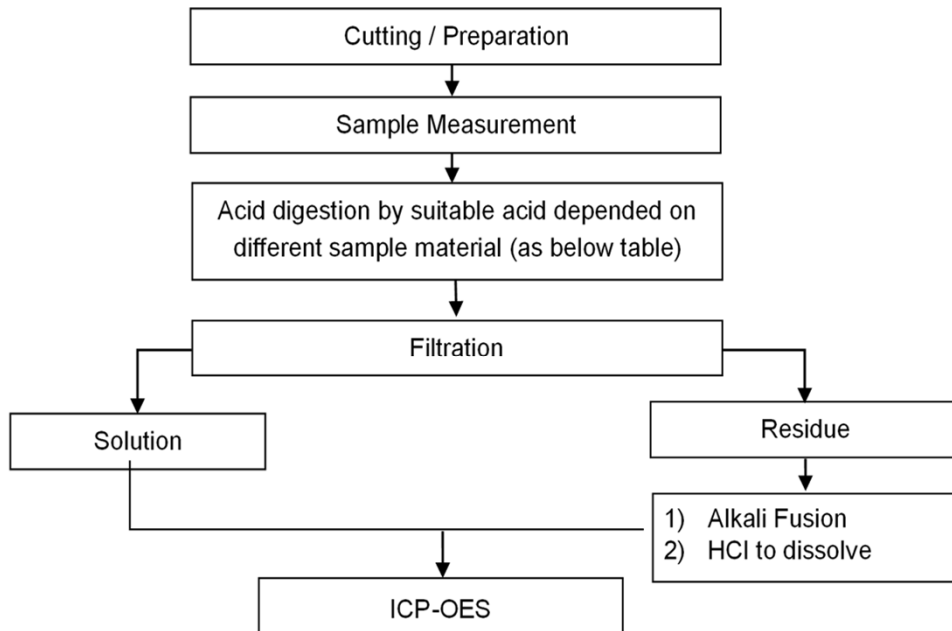

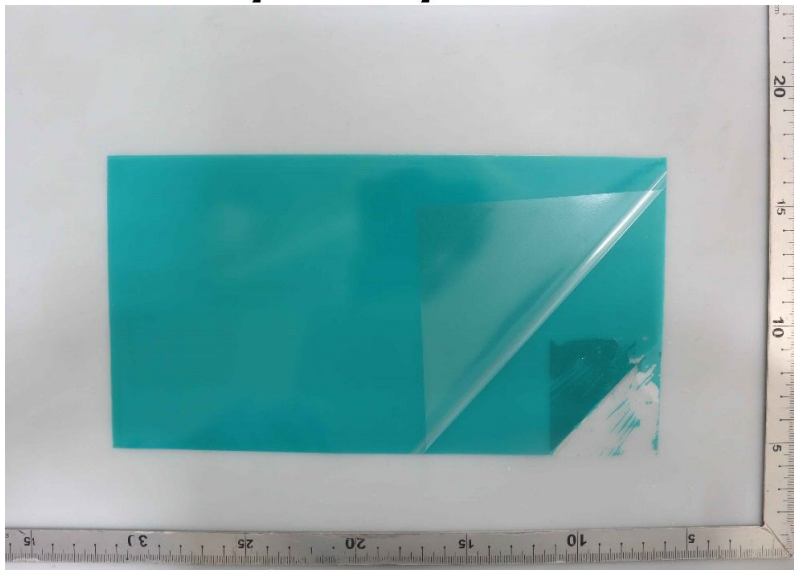
