

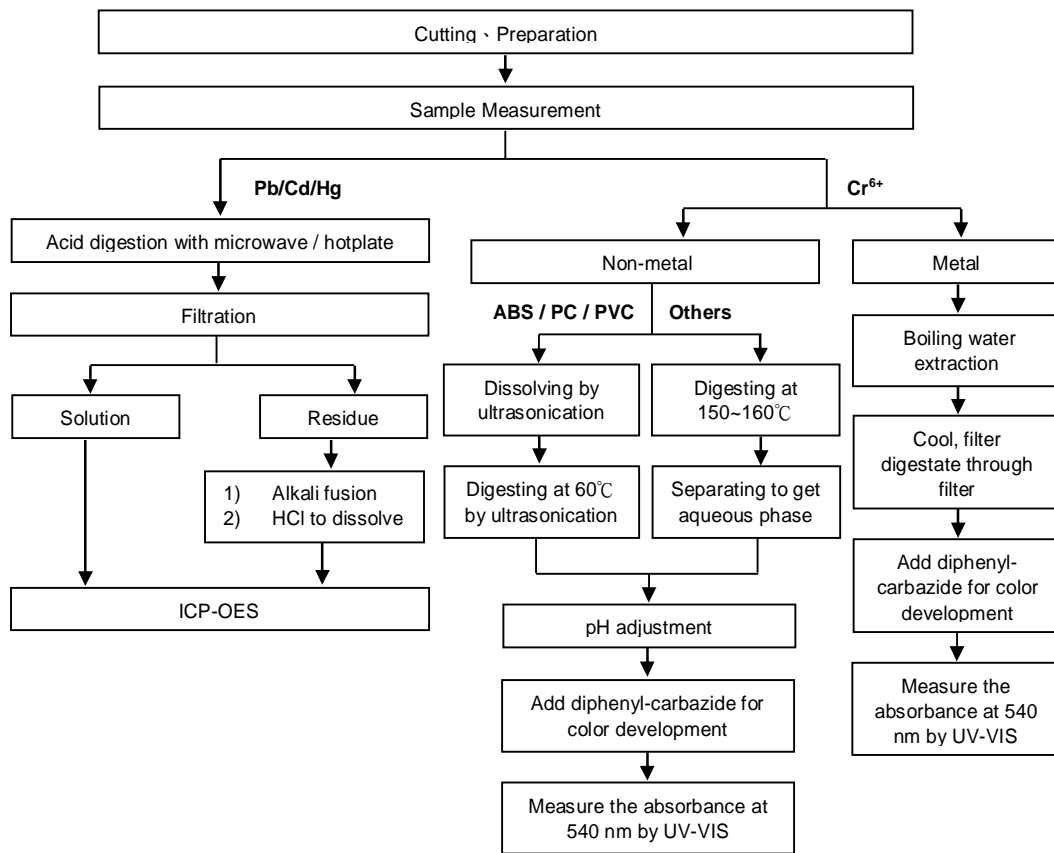

These samples were dissolved totally by pre-conditioning method according to below flow chart. (Cr⁶⁺ test method excluded)

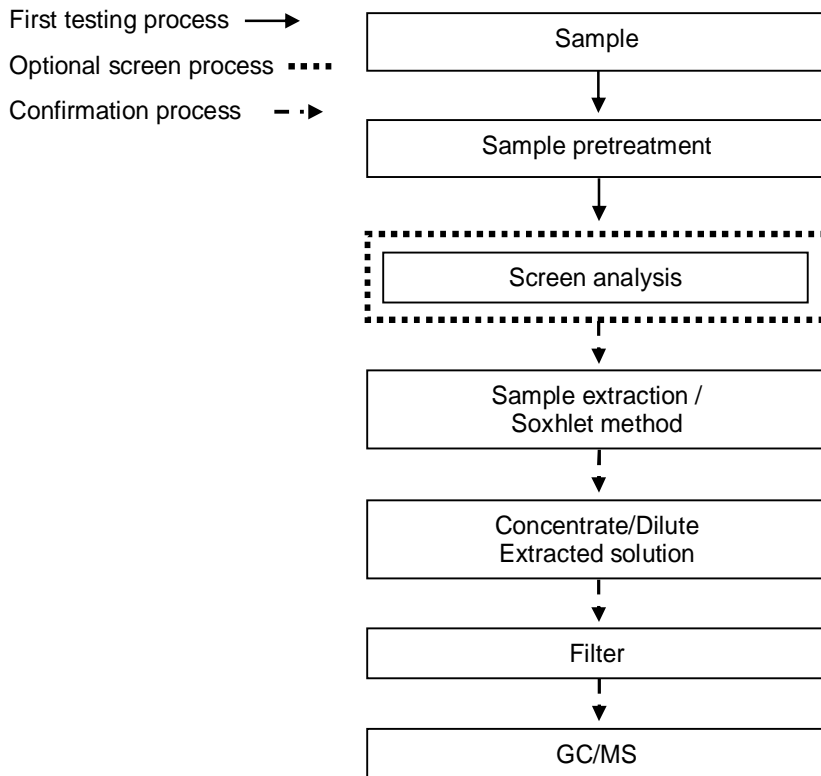

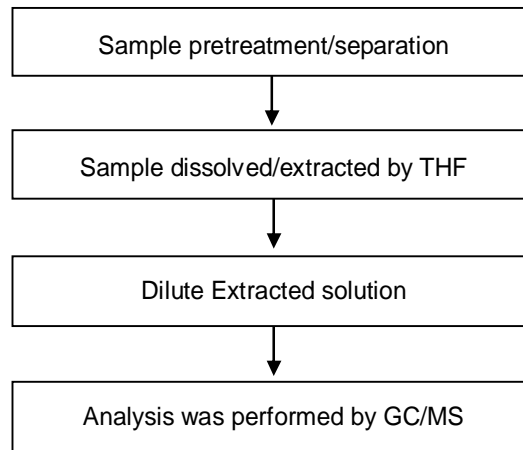
Analytical flow chart – PBB / PBDE

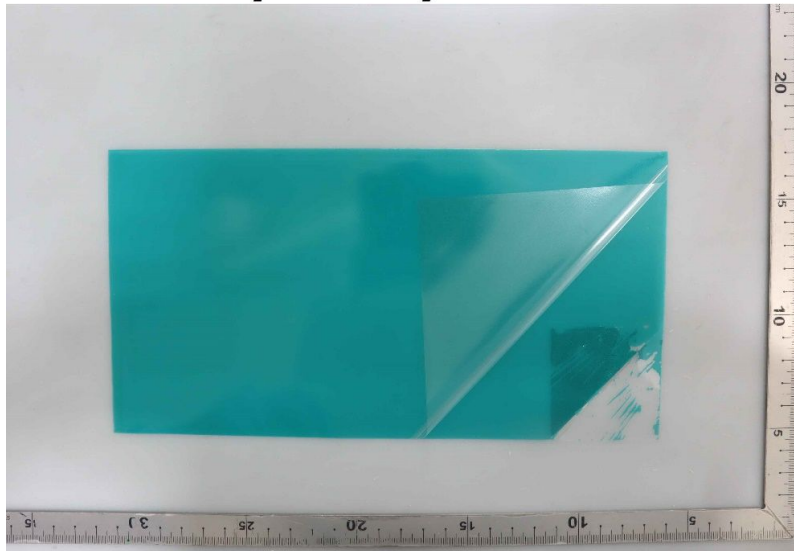
