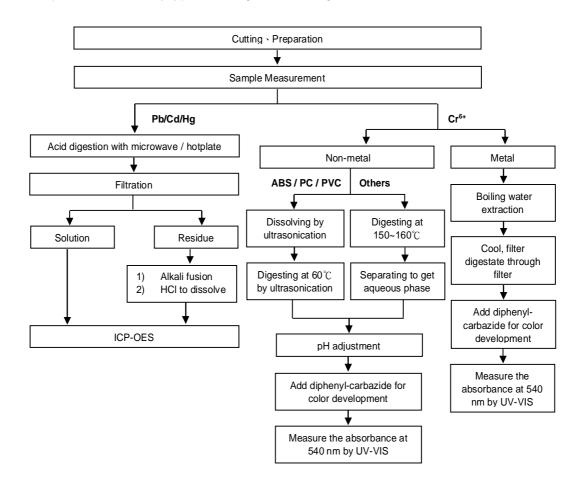

These samples were dissolved totally by pre-conditioning method according to below flow chart. (Cr6+ test method excluded)



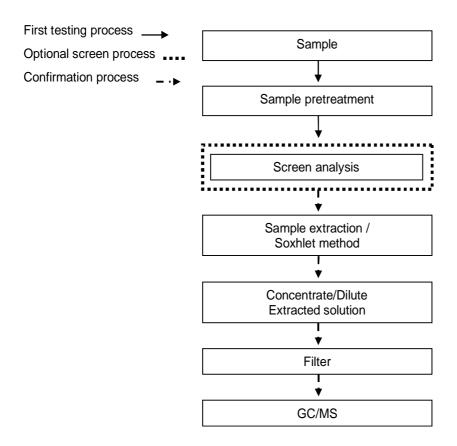

# Analytical flow chart - PBB / PBDE





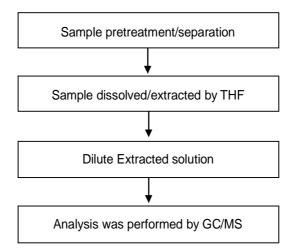

[Test method: IEC 62321-8]



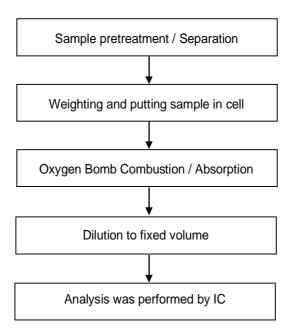

# Analytical flow chart - Halogen



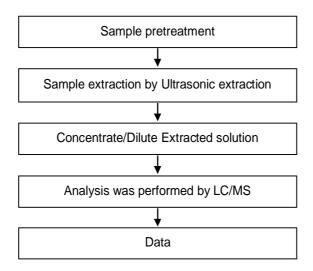

### Analytical flow chart - PFOA/PFOS





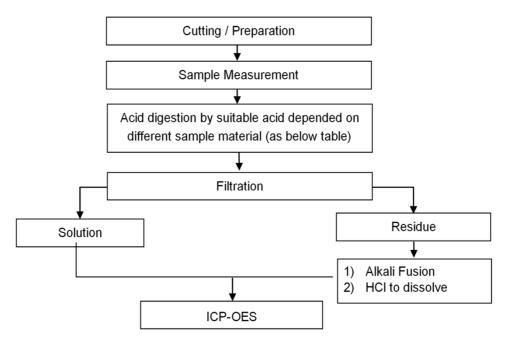
